

TASKS OF ORDER FOR A MEETING OF THE CONGREGATION

The following procedures and actions have been adopted in our constitution to conduct our work in ways that are both efficient and respect Gospel teachings in the decisions we make. Every effort to respect those participating as well as those affected by our decisions is cherished. Questions of procedure are always permitted, and can be asked of the Moderator at any point of a gathering. References to the sections of the constitution are in parentheses.

Meeting Procedure:

Meetings of the congregation shall be guided by Christian faith and teaching and the provisions of this constitution and by-laws, according to Robert's Rules of Order (newly revised), where applicable, to ensure a climate of mutual respect and orderly procedure. (Section 3.7.2)

Any member may request a written ballot for any vote, which will be honored without question.

Quorum:

The quorum for a congregational meeting shall be twenty-five members. (Section 3.2)

Parliamentarian:

At meetings of the congregation, the moderator will appoint a parliamentarian as an advisor on matters of procedure. (Section 3.7.1)

CONGREGATIONAL MEETING MINUTES

ANNUAL MEETING OF UNION CHURCH

Sunday, March 19, 2023, 3:00 pm

Welcome and opening prayer by Rev. Kent Gilbert. In this stage of Covid winding down, the meeting was held in person with the option of joining in online. Moderator Jean Boyce declared a quorum and appointed Vice-moderator Kim Kobersmith Parliamentarian. Rev. Kent introduced and recognized our staff for their hard work and dedication. Our paid staff are exemplary in their service to Union Church. There is much that goes on behind the scenes and we are grateful.



Jean Boyce, Moderator, reviewed the minutes of the Congregational Meetings for 2022 individually and asked for additions or corrections.

These included the Annual Meeting of March 20, the Budget Provision Meeting, July 31, and the Annual Budget Meeting, December 11. Minutes were accepted unanimously.

Rachel Lakes, Nominating Board, introduced the slate of nominations for Officers and Board Members. She expressed concern that there were missing nominations for Moderator, Nurture and Care, Worship, and Finance. She asked outgoing members to describe responsibilities of the position and then asked for volunteers. Steve Gowler agreed to be Moderator for 1 Year. The Nurture and Care missing position was filled by Susie Ritchie. Paul Jacobs volunteered to be on the Worship Board, and Robert Rorrer said he would be the bookkeeper on the Finance Board. Thank you to all who stepped up when needed. Motion presented by the Nominating Board, so it needs no second. The motion passed unanimously.

Honorary Lifetime Deacons were nominated this year for exemplary service to the church. Sometimes behind the scenes, Charles Hoffman has put in many hours working to our benefit on Finance Board, orchestra, and across the board. The same can be said of Gail Wolford in Administration. She's a careful observer and sees through to what is considered important. Both candidates endorse their love and humility among us. Acceptance of Honorary Lifetime Deacons passed unanimously. Nominations from Church Council need no motion or second.

Next on the agenda was review of the Annual Reports. Jean Boyce mentioned each report and gave time for questions or comments. In the Report of the Clerk, Bob Boyce asked that the congregation pay attention to those who passed away in 2022, and acknowledge their involvement in the church. He also asked that new members be accepted with joy and thanksgiving for their coming contributions. Betty Sarafin mentioned she would like to see a list of babies born to church members in the future. Carla Gilbert moved that we accept the Annual Reports as printed. Steve Bolster seconded this motion. Motion passed unanimously.

On to old business. In the Financial Report Shirley Carlberg commented that the Church Council looked at Operational and Actual Budgets each month. Toward the end of the year 2022 it looked like we were going to end the year with a deficit and we did. The Net Operating Revenue for the year was \$-17,645.15. The Lambert Fund yearly distribution, of which our Financial Policy directs we give 20% to each of five Boards, was used instead to offset the deficit. To prevent

ending in a deficit we had some reserves to put into use and ended on a good note. What was left of the Lambert fund was added to the endowment. Rev. Kent and Shirley agreed that financially we are okay for now but can't continue on this path. We have a strong endowment, Lambert Fund, ample money in the checking account, the Hutchins Fund for property expenses, and an Organ Fund begun by John Courter. The need to generate more income for several years to come is dire, especially with the costs of inflation.

Steve Bolster, Pastoral Relations Board, shared results of the Pastoral Survey sent to the congregation. Eighty five people responded, with most of those attending church in person and being sixty plus years old. Responses were generally positive about Kent's performance. More than half of the responses were 4.5 to 5, on a scale of 5 being the best response. Issues identified but not related to Kent were concern about the definition of member when considering online participation. Does worshiping online only with no other participation besides giving money count as a member? It is concerning to some that the number of people in the pews has declined. Another concern is that too much responsibility is placed on Kent. We may depend on his talents too much. A solution might be to spread some of his responsibilities to other Administrators or Nurture and Care Board. Stephen Ministry already shoulders some of the care of members.

Many churches are facing problems with declining membership. We as a congregation need to take a look at what we can do. Sue Peterson Blyth suggested devoting a group or task force to looking into what we can do to increase membership. After much discussion it was moved by Sue Blyth and seconded by Betty Sarafin to form a Membership Development Task Force that will answer to the Church Council. This was approved unanimously. The following persons agreed to serve on this task force: Carla Gilbert, Jenny Bromley and Sue Blyth.

Carla Gilbert pointed out that we are all empowered to invite people who might like to attend our services. And take the initiative to talk to new visitors and make them feel welcome. Sometimes that is all it takes to find a church home.

Sue also moved that we also adopt a task force to re-evaluate all of the usages of the present staff. She said "You know, we, we've been doing things a certain way and maybe we need to continue to do them, but I think we need to have an evaluation of that based on where we are financially right now." Jean Boyce and Kent Gilbert suggested that this go to Administration Board and it not be necessary to create a task force. Sue was asked if that would be sufficient and she agreed, so this was passed along to the Administration Board for consideration. Steve Bolster also offered that there were a number of comments in the recent Pastoral Survey regarding staff and staffing and suggested those be reviewed.

Installation of Board Members and Officers was the final business of the meeting. Rev. Kent, Jean, and the congregation followed an installation service. Prayers for guidance in using their gifts in service as Board Members and Officers at Union Church were offered. Officers and Board Members agreed to accept the responsibilities entrusted to them. Installation ensued.

Rev. Kent ended the meeting by leading everyone in singing the Doxology.

CONGREGATIONAL MEETING REGARDING BUDGET REVISION

Sunday, August 13, 2023, 3:00 pm

A quorum was present.

Rev. Kent was ill, so in his absence Steve Gowler, Moderator; Kim Kobersmith, Vice Moderator; and Dave Kobersmith, Church Administrator; led the meeting.

Steve Gowler opened with prayer.



2 Announcements:

- Our Grants Team (Rev. Kent, Bernardo Scarambone, Jennifer Elam, Sally Hindman, Nan Naumer) applied for a grant of \$302,000 from a private family foundation, that has chosen to remain anonymous. They will give us \$200,000. Funds to be used to hire a financial consultant from Generis (already hired) to assist with short- and long-term fundraising; provide kitchen management support; help with communications (to ourselves and to the wider community)
- Youth Director hired! Chris McKenzie was our Youth Director for 12 years, and has moved away from that position to go to grad school. Emily LaDouceur has been hired. Emily has been on staff at Berea Leadership Experience (BLE) for 4 years, is a Berea alum, former city council person and has 2 sons.

Presentation of 2023 Budget Revisions: As of June 30, 2023 Tear-to-Date Income vs. Expenses Income: \$199,763 Expenses: 222,083 Deficit projected of \$22,320

Revision for 2023

Income: \$393,111 Expenses: \$424,539 New projected deficit of \$31,428

Discussion points:

- For the past 3 years, the church has adopted a deficit and this is not the largest we've experienced. In years past, we have had large gifts make up the deficit and, in 2020 we had a Covid PPP loan that converted to a grant, since the church retained all positions.
- We did know at Dec. '22 meeting that this would be a deficit budget. The increase of \$7337 can almost be entirely attributable to the HVAC repairs of \$7500 made in early '23. The entire Properties Board 2023 budget was \$5000; and website maintenance has been over budget
- Our ministry is vital in the community
- Kim reported that she, Steve Gowler and Rev. Kent are looking at strategies to address our continuing deficits
- increase paid usage of building
- increase membership/giving
- ways to decrease spending
- Plate offering is up (that's the amount received on Sunday mornings, cash or check) Dave reported that going back to our pre-Covid custom of passing the plates in the pews has helped in that regard & thanked the Worship Board & Team for coordinating that
- Discussion of the church's reserve monies



- ♦ \$200,000 gift in 2020 we named the "Transformation Fund" has about \$80,000 left
- Our Financial Policy dictates that 4% of undesignated gifts be placed in Funds for Worship & Arts, Properties, Leadership Development, Community Life & Growth Projects and Mission & Service. We can choose to repurpose those balances (likely not Mission's Fund, as that goes out to their designees regularly)
- Grants what is being prioritized? Kitchen, a worship opportunity Kent & Bernardo are familiar with, fuel efficiency, consideration of building changes that would make it more marketable
- The world is very different now for small progressive churches than it was 40, 50 years ago. Hope to find experts who can help us navigate that.

After establishing that all questions had been answered and concerns addressed to folks' satisfaction, the question was called. As a motion coming from a Board it needs no second.

All in favor of adopting this Revised Budget as presented were asked to say "aye," and those opposed, "nay."

Passed unanimously


Annual Budget Meeting of Union Church Sunday, December 6, 2023, 3:00 pm

Reverend Kent Gilbert welcomed the congregation to the meeting and opened with prayer. Steve Gowler, Moderator, declared a quorum and named Charles Hoffman Parliamentarian.

Review of 2023 Year-to-Date Finances

Reverend Kent presented 2023 sources for funds, balances, and current resources.

- Donations Number one source
- Savings restricted and unrestricted
- Grants
- Investment Income



Unrestricted savings amounts to \$151,000. This is money available to pay for the deficit. But when it is depleted, in 3-5 years, that is it.

In 2020 the church received **grant** money, \$81,144, as part of Covid Transformation Fund. A 2023 Developmental Grant of \$176,000 was awarded for future plans.



Presently the major **investment** funds are the Lambert Trust Funds of about \$895,000. The yearly income is available for use. 2024 funds available are about \$44,500. In 2018 an endowment fund was started. Church policy is to request socially responsible companies when investing. Its current value is \$451,000. This fund is not available for use until it reaches \$500.000. The goal is that by 2028 \$1,000,000 will be reached. The interest may be used for 3 purposes: undesignated and unspecified needs, property and building expenses, and items given permission by the Church Council. The Church Council has discussed various ways to increase income.

Presentation and Discussion of Proposed Budget for 2024.

This years' budget shows an income of \$310,000, short of our \$320,000 goal. To compensate for the shortage steps taken will include:

- Apply for more grants.
- Work with financial consultants on strategies.
- Hire Communications/Development staff person. Hopefully seed money from the grant will provide sustainability.
- Use savings to pay current deficits.
- Explore income generating building uses.
- No staff cost of living increase. Maybe some cuts.
- Reductions across the board for ministry and administration.
- If the trend continues in Fiscal Year 2025, staff hours /positions will have to be cut.

Kim Kobersmith, Church Council Chair, called the question to accept the budget so it could be discussed. Because the budget was presented by the Church Council there was no need for a second. Greg Lakes, Treasurer, pointed out and explained some changes in the budget from 2023. A member of the congregation asked if these cuts will affect our mission. Rev. Kent replied that they will. A different approach may be needed or an evaluation of the importance of what the church wants to accomplish. Sue Peterson Blyth asked how Properties Board funds are spent. Dave Kobersmith mentioned property insurance, repairs to the HVAC system and sprinklers, yearly sprinkler and fire alarm inspections, and utilities. More detail about grant specified items was requested by Gail Wolford. Rev. Kent explained that some grants include 3 – 5 year financing, some 2 years. We will have to decide how to sustain and whether to continue or not. The Development Director will probably be a grant funded position.

Steve Gowler, Moderator, called for a vote to adapt, modify, or reject the 2024 Budget. The 2024 Union Church Budget **passed unanimously**. Rev. Kent reported enthusiastically that the people of the church make things happen. They keep their eyes and hearts open. Wednesday night dinners were one response to the needs of the hungry. Warm clothing was needed by people of our



community and a collection began. The Wednesday night Thanksgiving dinner reached many people who did not have anywhere else to go. Food and comradery were provided to Berea College International students, homeless people, lonely individuals, and more. Rev. Kent closed the meeting with a blessing.

ADOPTION OF THE 2024 BUDGET POLICY

The Annual Operating Budget for Church of Christ, Union is the primary instrument of financial planning as established by the Constitution of the Church. Preparing an Operating Budget allows the congregation an opportunity to express their desires in the operations and management of the Church. By passage of this document, the Congregation empowers the Church Council with the responsibility of handling and controlling the Church's finances using the Operational Budget as the adopted guideline.

With the adoption of the 2024 Operational Budget, the Congregation makes the following policies as a part of this Budget:

The Operational Budget document stands on its own merits. Any previous Budget directives as passed by the Congregation and/or Board or Church Council are not valid unless further addressed within this document or the Church's Constitution.

The Boards and Officers are empowered to expend up to the amount allocated in each of the primary Total Expenditure Classifications: Personnel, Administration, Church Finance, Property, Faith Development, Worship, Nurture & Care, Mission & Service, and Community Life & Growth. With the exception of Personnel and the line item for a pastor's professional expenses, board chairs and Church Council can approve a request that will result in an overrun in the other Expenditure Classes of not more than ten percent (10%) of the budgeted amount. Lacking approval for a classification overrun, the Treasurer will not authorize any further payments from any line item in the classification. Projected increases or overruns in the Personnel Class, including Pastors' Expense Accounts, must be first approved by the Congregation.

The Church Finance Board is empowered to expend up to \$5,000 without further Congregational approval for emergency items not identified in the Operational Budget (for example, ceiling repairs in the sanctuary.) Should an expenditure of that nature be required, the Church Council must decide whether to withdraw funds from reserves or ask for a special offering appeal and must report the action(s) to the congregation.

The Church Council must report the financial conditions of the Church with respect to the Operational Budget on a regular basis through reports to Church Council meetings and other means as necessary.

Board Chairpersons who have funds at their disposal through the Budget are responsible for tracking the expenditures of their boards. Monthly financial reports will be distributed at the Church Council meetings for this purpose.

Designated giving toward special projects and other non-operational items must be approved by the Church Council prior to creating a new fund for acceptance of the gift. Upon acceptance, those moneys will be handled as Non-Operational Activities and do not appear in this document and do not require further Congregational approval unless stipulated by the Church's Constitution.

The Proposed Budget will be available for Congregational review at least one week prior to the meeting at which it is to be presented for adoption.

If a surplus remains at the end of the year, 10% of that surplus will be placed in the Mission Outreach Fund and 10% added to the Union Church Endowment Undesignated account. The remaining 80% is to be allocated as recommended by the Church Council.

APPLICATION FOR A 2025 CLERGY-CONGREGATION RENEWAL GRANT

In our covenant with our pastors, the congregation offers a 3 month sabbatical period after every 5 years of service. This time releases the pastor from all duties and offers time for rest and renewal impossible under the conditions of daily ministry. The pastor is obligated to stay for a full year after the end of sabbatical (at least), to bring the fruit of his or her time apart back to the ministry of the whole church.

Rev. Kent's last sabbatical took place from July 1-October 31, 2019, making him eligible this year. In conversation with the Pastoral Relations Board but planning and current church finances would be improved with a delay until 2025. In their investigation they learned of the Eli Lilly Foundation "Clergy Renewal" Grant program. If funded, this grant would provide up to \$20,000 to the congregation for a program of support and renewal in the pastor's absence, and would provide him up to \$40,000 for travel, education, reflection, and renewal. Successful proposals include active and enthusiastic congregational participation in the planning, and so PRB presented a proposal to form a team to make a submission in March 2025, using this time to dream and plan.

This was approved at the February, 2024, meeting of Church Council and now comes before the congregation for discussion and a vote on endorsement. Since involvement of the whole church is crucial to a successful sabbatical of this kind, we hope to engage the discernment and the insight of the widest possible circle.

Motion: That the Congregation together with the pastor and pastoral relations board work together to design a sabbatical program for both Rev. Kent and the members of the church and apply for a Lilly Foundation Clergy Renewal Grant in the spring of 2025.

"Lilly Endowment Clergy Renewal Programs provide opportunities for pastors to step away from the persistent obligations of daily ministry and engage in a period of renewal and reflection. Renewal periods are not vacations but times for intentional exploration and reflection, for drinking again from God's life-giving waters, for regaining enthusiasm and creativity for ministry.

Clergy Renewal Program are open to Christian congregations whose pastors are serious about congregational ministry and who can envision the program as a means of renewing the pastor's commitment to the congregation and ordained ministry. The annual programs are designed for those congregations and pastors who have a strong relationship with one another, a high degree of mutual trust and support, and are eager to see their relationship strengthened, renewed and continued."

REPORT OF THE MODERATOR



My one-year term as moderator comes after I first held the position more than twenty years ago. Then, I succeeded Dr. Warren Lambert, who had served as moderator for over 45 years. This time, I followed Jean Boyce, who graced our congregation with large-hearted and conscientious dedication. It was humbling to follow such leaders.

This has been a year of searching reflection about Union Church's financial standing and about how our congregation can most effectively meet the challenges of the changing national landscape for progressive churches like ours. I had the privilege to sit with our Church Council each month where these issues are considered prayerfully and creatively. That

experience reminded me of how fortunate we are to have such a talented staff and team of board chairs. One idea coming out of those discussions was to consider ways to strengthen the relation between Union Church and Berea College. We are in the early stages of dialogue with the college administration about how we might reimagine the historical connections between the church and the school.

A highlight of the year was welcoming new members to our congregation, many of whom are already making their mark on the life of the church. Other highlights include the success of our Wednesday evening meals and programming, the worship service lead by members of the church's youth group, and Kent's tireless work with the Kentucky Council of Churches to speak truth to power in Frankfort.

"And from his fullness we have all received, grace upon grace." ~John 1:16



Within days following the incident we moved essential equipment for broadcast to Cowan Chapel, worshiping there from the beginning of January through February 12, while



carpet and sodden pew cushions, debris and wood scraps were removed from the sanctuary. Our worst fear was that the 100 year old sanctuary floor would swell and buckle from all the water. Fortunately, thanks to the quick action of so many volunteers in quickly vacuuming and dehumidifying, the floor was saved and only needed refinishing, not replacement.









While we worshipped in the chapel, scaffolding was installed on the Boone Tavern side of the main sanctuary in order to repair the ceilings, plaster and fixtures that were either damaged or had to be removed. After the overhead repairs were completed, restoration work continued well into July, but the



congregation was able to return on Sunday mornings in time for the Lenten season. With structural repairs complete, we turned our attention to replacing pew pads, painting, refinishing damaged wood, and finally installing new carpeting. We are deeply indebted to Mr. Mike Bryant of Twin Hammers Construction and the talented crew who moved swiftly and carefully to restore this historic house of worship.

Needless to say we were extremely glad that our property insurance covered almost all of the \$158,000 of cost. Unfortunately, this claim caused us to be canceled by our carrier as of December 31, 2023. Many other churches suffered the same fate nationwide as church insurers tightened their requirements and shed contracts by the thousands. As ever, it seems, we were trendsetters, but in this case not in a good way. As of this report, we are still seeking affordable replacement coverage, but with the prospect of at least doubling our previous premiums. It remains a formidable challenge to us, especially having seen the damage a single sprinkler head caused in under an hour of failure.

Grant Team and Grant Success: In February, Church Council endorsed the founding of a Grants Team to pursue additional funding that might be available for support of the church. Nancy Naumer, Sally Hindman, Bernardo Scarambone, Jennifer Elam formed the initial group.



Their hard work paid off in several respects: first we collected the kind of common information grantors frequently request so we can easily add it to every application. We began tracking several new opportunities for churches (including some from the "Inflation Reduction Act" that aim to combat climate change by helping non-profits improve energy efficiency), and we successfully applied for and received a \$200,000 grant to build community through our Open Table program, engage in financial planning and hire a Development Director, as well as explore a new communications

strategy to help others learn about his unique place.

We applied for, but did not receive, a Kentucky Voices for Health grant to help address opioid use and support of affected persons, but we think future opportunities will be forthcoming. We had hoped our partnership with the University of Kentucky "Drop In Center" which was meeting at Union Church would be a program we could grow. However, our location proved to be less advantageous than other settings closer to parking and unsheltered populations. We continue to look for ways to be supportive all family and friends affected, however, and remain on the lookout for ways to serve them.

Worship and Attendance Trends: Throughout 2023 we saw a slow but steady increase in in-



person worship attendance. Easter service culminated in the largest congregation since the pandemic with approximately 200 in the sanctuary. In the fall, with the return of musical programs, participation in these groups has also continued to grow. Our Wednesday night "Open Table" Community meal program saw increases from 25 people in the initial weeks to routine crowds of 80-100 persons. This is encouraging on several levels and I believe speaks to the human need for

connection we are all experiencing, and a re-acclimation to group activities. It is my hope and prayer that the church can continue to be an intersection point for community and commitment, prayer and service as we move forward.

Staff Changes: Significant staff members made transitions in 2023. Chris McKenzie, who served as Youth Director for more than 12 years, stepped down to pursue additional education and responsibilities at his full-time work with Grow Appalachia. Fortunately a vigorous and engaged search team interviewed a number of very qualified candidates and selected Emily





LaDouceur as Youth Director. She joined Courtney Parrish, hired earlier in the spring as Assistant Youth Director, and came on board in August to launch fall Youth Group programming. Shirley Carlberg, Bookkeeper since 2016, and volunteer Treasurer for several years before that, retired early in '23, and Robert Rorrer was hired for that position.

Thanks to the grant mentioned above we were able to hire

Ms. Deb Beishline as chef and kitchen manager. Deb and her talented crew of volunteers prepare the Wednesday meals and have undertaken the task of organizing our kitchen for efficient and loving service. Jesus knew that food was the way to bring people together and the addition of Deb has proven it so in our time, too!



Late in the 2023, Pearl Marshall, Handbell Ensemble Director, stepped down after many successful years guiding the choir in response to changing family needs. The budget shortfall meant the painful decision to

move forward on a volunteer/ad hoc basis in 2024. Grant funds have been solicited to restore the position, but as of this report we've not heard whether that grant will be funded. If congregational finances improve, we hope to be able to hire again as soon as possible.

August Covid Recurrence: In August the area suffered a resurgence of Covid-19 and after exposure at a funeral service, I came down with an active case. Many of our members did as well, but I'm glad to report that everyone came through safely. In my own case it was the first time I had suffered any symptoms. The infection that I contracted in 2020 was entirely "silent," but left me with "long Covid," as I've reported in previous annual reports. Fears of moving back to the debilitating symptoms of 2020 and 2021 were not realized, and instead, after the initial weeks of recovery from the August bout, I noticed that I continued to improve past my previous "norm." By late October it was very clear that all traces of my long Covid had finally lifted, ending over three years of struggle. Whether it was the anti-viral treatments I received for this second infection, or whether 33 months was just enough, I'm very glad to have come out of the other side!



I continue to pray for all of our members with Long Covid symptoms to be able to say the same and of course remain available for any and all support they might require.

100th Anniversary of the Building of the Sanctuary: A great highlight of the year came in September as we finally were able to celebrate the

centenary of the historic "Fee Memorial Chapel," completed in 1922. Covid infections and concerns in 2022 prevented us from celebrating then, but if we

were delayed by a year, it only compounded our joy in representing this space and the numerous ways it has nurtured important service over the decades. The theme "Grace In This Place" ably allowed us to delve into our own history and look forward to new years of



service here. Great thanks go to the whole planning committee, but especially to Donna Lovell, whose meticulous spelunking in our archives revealed a hidden history of design, hopes, and adversity overcome. Our September 24th, 2023 re-dedication festivities included a recreation of worship from 1922 in the morning with the Rev. John G. Fee visiting from beyond the grave, and an afternoon with ribbon cutting by Berea Mayor Bruce Fraley, Berea College President Cheryl Nixon, and architectural historian Dr. Robert Boyce. All three offered remarks which were followed by a musical performance, tours, and wonderful food by Chef

Sad Losses: Sadly, the fall that saw the restoration of my own health also brought the deaths of great pillars of the congregation. Loyal Jones and Doug Hindman both made incredible contributions to the life of Union Church and their absence echoes through these subsequent months. The church family feels the absence of Joyce Mosher and Tom Parker, who joined the wider life in 2023. I was honored to share in the remembrance of Polly Embree, a Fee descendent who was memorialized in Berea. I record here the gratitude of their families and friends to the members of the Union Community, who helped sustain them in life with

Deb. The afternoon program and Order of Worship are on pgs 50-53 of

this report.

your friendship and support, and who honored them after their passing with services of dignity and grace, remembering God's great gift to us through their lives. They

are deeply missed as we try to carry their legacy of service forward.

Looking ahead: As ever, it seems, constant change is the only

constant in the life of faith and faith communities. Union Church continues to be a place of incredible energy and inspiration and also continues to struggle with financial shortfalls, despite so many hopeful signs. To address these changes, the aforementioned grant has afforded thurch finances. Thanks to good eaching and the outroordinary.

us access to experts in church finances. Thanks to good coaching and the extraordinary generosity of members and friends we were able to increase pledges and gifts by over 11%. We have been diligent about cutting costs **and** investing in meaningful service, both critical to our mission to meet what Love demands. That resulted in a lower than projected deficit in 2023 but still a significant shortfall. While we still have reserves should we not receive enough 2024 funds to cover costs, we are actively and earnestly working for sustainable ways to follow God faithfully, boldly, and creatively.

I'm excited that as of this report, we are very near to offering a new ½-time **Director of**

Development and Congregational Engagement position that is grant-funded, and will bring onboard someone to help us cultivate generosity, grants, and just good relations across all the people and places where Union Church makes a difference. We're hoping this prayerful, intentional work will help us meet the needs of good ministry here and do so in a way that feels empowering, not depleting to all of us who support this unique expression of God's love.

The person in this position will give us 20 hours more brain and heart power to help members connect, help grantors know the good work the congregation undertakes, and to help tell the story of impartial love at work. Combined with the

loving generous gifts all of you already provide, we hope this will begin to eliminate deficits and through legacy gifts support future vision even after some of us have "gone on to glory."

As mentioned above, property insurance will likely continue to be a significant challenge to us.

Our 2023 policy cost \$13,500 with a \$1000 deductible. It is clear that even the sweetest deal that we are likely to receive will be at least double this amount with deductibles in the 10s of thousands of dollars. This is a national trend but not helped by our recent claim. In order to make best use of this magnificent facility, and to help defray the costs of its insurance and maintenance we are already looking at how to offer the space in creative ways to creative partners. Whether this will turn out to be much needed day care, a school program, or a



non-profit incubator, we hope to serve the community and prosper our ministries at the same time in these kinds of partnerships.

And finally, 2024 will bring planning for another sabbatical, most probably in 2025. The

Pastoral Relations Board with the endorsement of Church Council would like to apply for a special "Clergy Renewal Grant" from the Eli Lilly Foundation. We will need to work together as a congregation toward a project of rest and renewal for both pastor and people, but if we are successful, the grant would pay for special resources for the congregation while I'm away, and provide funds for both Diana and I to refresh for rejuvenated service upon return. More details will be forthcoming, but we'll be looking for volunteers to help devise what would "make our hearts sing" after so many hard years.

As I write this we are completing our 27th year of service together. In March 1997, when I first began preaching and wondering how it might all

turn out, I certainly did not expect that Union Church, its people and its mission, would become so dear and so integral to my whole life. It has, and I am grateful to have found service that continues

to be challenging, meaningful, and healing alongside all of you. That said, longevity is no virtue in and of itself. It is only valorous if it continues to lead to "grace upon grace" as the scripture says. I pray that as the church reinvents itself for a new age and new ways to express God's love that our long partnership will help smooth the curves and steady the hard bumps. But I also hope that we never take the gift of such partnership for granted, or fail to see all that is newly required of us as God's grace unfurls. Help me in this, I pray. Let's keep attentive, active, and alert for where the Spirit might be calling, then let's go together into whatever God holds.



Remade over and over the centuries into loving service, the Christian enterprise has ever been renewed in strength and capacity when we allow ourselves to take whatever shape will hold God's ageless love in new ways and new places. Let us explore and follow, my friends. I'm excited to continue this journey ever Godward in your midst.

REPORT OF THE PASTORAL SUPPORT ASSOCIATE



As I prepare this report of the previous year, I am reflecting on the occasion of my 40th year Anniversary of my Ordination in the United Church of Christ in January of this year. I am in awe and wonder that I have been given the privilege to continue in "professional ministry" long past retirement age, so to speak. (I say I can't retire because I don't know what I'm going to be when I grow up :>). At any rate, it is even more awesome and wondrous to be able to serve as a member of the staff in Union Church and even more so in collegiality with my son, added to the fact that rarely do mother/son serve as pastoral colleagues. At one point we were told that we were the only mother/son team in Pastoral Ministry in the whole denomination. I am mindful of a short prayer: "Help! Thanks! Wow!"

According to the position description, the purpose of this position is the responsibility for resourcing and supporting the spiritual needs of church members in crisis or long-term distress. However, it is also to provide resources to support those needs for church members and friends in general. This is done in consultation with the pastor on a regular basis in conversation and guidance in that process. It is important to know that confidentiality for both pastor and associate are of utmost importance and all conversations between them are not automatically shared.

My defined tasks are:

- Pastoral liaison for the Nurture and Care Board, which specifically includes ministry to those family members who are grieving the immediate loss of a loved one by delivering Grief Bags to them when possible: an evergreen in a vase to remind of God's eternal presence, a loaf of home-baked bread to share in the way in which Jesus shared the bread of life with others, and a votive candle and holder to light the way when it seems so dark, knowing that the Light shines in the dark and the darkness could not overcome it!
- Pastoral liaison for Stephen Ministry as a Leader, matching care-givers with care-receivers to provide support and affirmation as they serve those in need of care.
- Facilitation of Memory Keepers, a bi-monthly meeting for members and friends who have loved one experiencing the various kinds of memory loss. In addition, to serve as a resource for some special needs in that process. We meet by Zoom the first and third Tuesday of the month to enable those who cannot leave their loved ones to participate, and currently have
 - folks who tune in from the local area of Berea and Richmond, and also from Michigan, New York, and Maryland. Our alumni serve as folks with past experience with supports those who are immediately in that role. The group is open to all; confidentiality is respected and support graciously given.
- Occasional pastoral counseling for member and friends of Union Church and community members, including occasional officiating at wedding or memorial services when needed.
- Other specific needs requested by the pastor or staff.



I also lead a weekly Bible Lectionary Study for members and friends. This is also a Zoom meeting which meets on Thursdays at 10:30 am and includes several folks from the immediate area as well as from Florida, Michigan, and Arizona. It encourages each to share their experiences and observations regarding life and the scriptures for the following Sunday – with no wrong questions or answers. All are Welcome!

Again, many thanks to Union Church: its staff, its members and friends for the privilege of serving this wonderful community who truly does "walk the talk" as "Love Demands".

REPORT OF THE CHAIRPERSON OF CHURCH COUNCIL



As the coordinating body of the church, our early discussions about reenvisioning our ministry reflected that we were still feeling the effects of the pandemic. Through the year, we saw a flourishing in both programs and involvement through the Connexions college group, choir and orchestra, Open Table, Monday Drop-in resource day, a new Compline service, and Youth Group.

On-going conversations centered around how to shift our budget to meet our current income. The council committed to work on the budget throughout 2024, not just at the typical late fall time, including assessing right staffing levels.

These were the actions we took this year:

- Coordinated a celebration of 100 years of our historic sanctuary building
- Endorsed Seth Hutchins in his application for UCC ordination
- Approved spending of Hutchins Fund moneys for HVAC repairs, playground surfacing material, and painting in room 101
- Affirmed work by the grant committee which garnered a \$200,000 grant for a financial consultant, a development director, and support of Open Table
- Approved spending Transformation Fund moneys to hire an audio visual assistant and invest in communication tools (banners, direct mailings, etc.)

REPORT OF THE CHURCH ADMINISTRATOR

The beginning of this year was consumed with getting repairs done on the building after the



December 27, 2022, sprinkler head break in the Sanctuary. This caused damage to the Sanctuary and Community Room (see 2022's report for extensive list). I worked with our insurance adjusters and looked for a project manager to give us a complete quote for all the work that needed to be done. This was hard to come by due to all the work that was created by the polar vortex that occurred in December of 2022. In mid-February I found Twin Hammers, owned by Mike Bryant, and was given a quote that was accepted by our insurance adjuster after a six week evaluation of his

quote. The quote was for \$157,370.

Work began in April and was completed by the end of June. Although we did worship from Cowan Chapel in early 2023, by the time the work was being done by Twin Hammers we were able to worship in the sanctuary while the work was underway. We are indebted to Mike and his crew for the excellent work and how quickly they were able to get it done.



In August I assisted Kent in working with a consultant to help us with all things related to giving. We were guided in our stewardship

work in the fall, which ended in a celebration during our worship and gathering afterwards. Together we wrote a fundraising plan and the consultant is helping us in the hiring of a Director of Development. This position will be funded from the Development Grant account which was funded by



anonymous family foundation. We are hopeful this guidance will help us in funding our ministries well into the future.

In September we learned our insurance company, Church Mutual, would not be renewing our policy when it ended on December 31, 2023. We were told this was due to the large claim earlier this year. We learned over time that the insurance company dropped many churches all over the country. This has made it difficult to get insurance for churches, including ours.

Last year our insurance, liability and property, cost about \$13,000. Currently we only have liability insurance at a cost of \$4,000. The only quote we received for the property insurance was over \$60,000 which we can not afford.

Although the work we are currently doing is not a part of 2023, I think it is important to share what is being done. We are looking into options with Berea College and United Church of Christ Indiana-Kentucky Conference. Our goal is to learn if a partnership would help us in getting insurance. There are many complexities regarding this topic, but I want all to know we are working diligently to protect our property where many of our ministries and community programs and events occur.

You will find other work I supported by reading the reports from Administration, Finance and Properties Boards. Thank you to those wonderful volunteers who I have the pleasure of working alongside.

DIRECTOR OF MUSIC MINISTRIES

As we planned, the year of 2023 was a reconstruction year, after several years of dealing with health issues, distancing, and sickness with pandemic. With the hybrid services (online streaming as



well as live service), all music personnel had to become way more conscientious about microphones, sound checks, and all the procedures involved in recording music and sound balance.

The choir has been growing steadily since then, and we alternate singing from the balcony with performances from the floor. Several choir members prefer to sing from the floor and feel closer to the congregation, and the feedback from the congregation has been positive when that happens as well. As the choir grows, some selections have to be sung from the balcony, so we will keep alternating formats depending on the season, and repertoire. For example, during Lent and Advent, we

will sing from the balcony. During summer and other seasons, we will

sing from the floor and so on.

One of the highlights of the year was the Christmas Cantata. For the first time since 2018 at least, we presented a Christmas Cantata on Sunday morning service. Luckily, in 2023, Christmas Eve was on a Sunday, so the Cantata was a perfect addition to the morning regular service. The Cantata was a great experience for everyone involved because we were able to create a sense of community among singers, readers, orchestra, narrators, and dancers – all working to create a unique experience for the



congregation. The result of the Cantata was a growth in choir members who could experience how much it is to make music together! I plan to do another Christmas Cantata in 2024 if everything goes well!

The Orchestra has been meeting consistently and we are also growing in numbers. We worked with a program for the youth and at least three members of the youth program are coming and playing with the orchestra – There is always more space for people to join. I arrange all the music according to each instrument and level of each musician, so everyone sounds good and we are able

to make beautiful music together.



Often we combine choir and orchestra in special occasions and repertoire, sometimes with soloists, sometimes with selected instruments. All the potential options allow the music in church to be very varied and diverse, not only by repertoire selection, but also by using different instrumentations. And when large groups are still learning and perfecting the music, I play solos on the organ and piano. All repertoire is carefully chosen to fit the church calendar, as well as the ability of each group and function in the service.

In addition to the choir and orchestra, we often have guest musicians who share their talents with us. From professional groups to students, we are lucky to be able to listen to an even greater variety of music in our church.

One bittersweet note refers to the bells. Pearl left Union Church after 10 years leading our Handbell Ensemble and we are in the process of continuing that ensemble in a member-led structure. Bells have been such an important part of our musical tradition, that we will keep it going!

I tried to continue with the variety of music offerings to match the diversity of our Church. We played pieces from various styles, from different countries and composers, but always mindful to the message and meaning that only music can create. Looking into the future, we want to grow even more the choir, the orchestra and continue creating opportunities for everyone to make music through worship.


Chris provided during their tenure in their roles and equally grateful to Courtney and Emily for the care and leadership they exude in their support of our youth.



With Covid still haunting public gatherings, the Mission and Service Board met via Zoom until the fall of 2023 when we began a hybrid model with some members attending in person and some online.


In April, we sponsored the third annual "Blessing of the Gardens" at the Berea Urban Farm. Rev.




REPORT OF THE NURTURE AND CARE BOARD

Nurture and Care Board Members have met occasionally, however, the ministry of this Board has continued, thanks to the diligent oversight by Board Members who have continued their given responsibilities which are as follows:

Hazel Morris sent out 348 Birthday Greetings in addition to cards for special occasions such as Anniversary cards (10); and Holiday cards to those in assisted living facilities and home care and people who have moved to other states to be closer to family as well in Berea, Richmond, Lexington, and Somerset. Although Hazel finishes her term on Nurture and Care, and Donna Lovell has graciously volunteered agreed to send birthday & other cards, Hazel will continue to send special occasion cards for the monthly holidays to friends in Assisted Living and Nursing Homes. Rhonda Cardwell has had the major responsibility for overseeing special receptions which have been primarily those following Memorial

Ministry to those family members who have lost a loved one become a part of our ministry. Each immediate family member receives a Grief Bag delivered where possible by **Rev. Carla** or **Rev. Kent** which includes a beautiful vase with an evergreen, a glass votive candle holder made especially for Union Church by Michelle Weston, a votive candle and a loaf of bread

made by former N&C Board member, **Gerrie Blanchard**. In addition, The *Permission to Grieve* series of booklets are sent to those family members throughout the first year after their loss. **Donna Abner Rath** sent 64 books this past year. Thank you, Gerrie and Donna, for your spiritual caring during these times of loss when Love Demands a certain response.

Stephen Ministry also falls under the purview of Nurture and Care Board. Over the course of 7 years Union Church has

trained 20 caregivers who have each had more than 50 hours of intensive support training as well as follow up support with Peer Supervision and Continuing Education. The ministry is coordinated by

Rev. Kent, Jen Eich, and Rev. Carla. At this time, we have 9 active care givers, some who were in the first class of the beginning of the program 7 years ago. In addition, Stephen Ministers assist with the Long Night Service, held on the longest night of the year as a time to support those who are grieving and those who support them. At present we are assessing the specific needs of this ministry with regards to Leadership, Care-Givers and Care-Receivers. If you have interest or comments, please contact Rev. Kent. This is a valuable ministry that is not only for our church members and friends, but those within the local community who need support during a critical transition with utmost confidentiality. REPORT OF PASTORAL RELATIONS BOARD



(amended 3.17.24, changes in RED)

In March, 2023, the members of the Pastoral Relations Board studied the complete, detailed set of results from its Spring, 2023 Pastoral Evaluation of Rev. Kent, which were overwhelmingly positive and affirming of his work

as pastor. The Chair of the PRB (myself) made a presentation to the Church Council at its March, 2023 meeting, including a detailed report and summary of the survey results followed by a discussion of the implications for future action.



The Pastoral Relations Board did not meet during the summer and fall of 2023. There was little business during this period of time.

The main agenda item for the board's January 25, 2024 meeting was a discussion of Kent's next sabbatical, tentatively planned for the spring and summer of 2025. In particular, Rev. Kent introduced board members

to the possibility of Union Church applying for Lilly Clergy Renewal Grant to help cover the expenses of the proposed sabbatical. After a vigorous and detailed application process, approval by Lilly would provide up to \$40,000 to the pastor and \$20,000 to the congregation towards expenses incurred during the sabbatical. The challenge in regard to a possible 2025 sabbatical

was that the application, which required considerable information, input, and planning both by the pastor and by the congregation, was due in mid-March, 2024, just a few weeks away. After much discussion and reflection by board members during the week following our January meeting, and after subsequent discussion by the Church Council at its meeting on February 19, it was decided that the application for the Lilly Clergy Renewal Grant would be postponed until



March, 2025. The funds provided by the grant, if approved by Lilly, would then be available for a six-month-long sabbatical in the spring and summer of 2026. Postponing the grant application to March, 2025, and the sabbatical for a year until 2026 would allow for a solid, well-planned, and clearly-articulated grant application. Various groups of Union Church would be involved in the planning for and the writing of the grant application, including members of the Pastoral Relations Board, members of other boards and the Church Council as appropriate, and the new Grants Committee, as well as the Pastor himself. In the meantime, since the sabbatical



would be delayed, the Church Council approved that the church grant Rev. Kent a two-month leave of absence during the spring of 2025 that would be funded essentially from funds already set aside for pastoral leave. A detailed proposal for this shorter leave would be presented to the Church Council by September, 2024.

REPORT OF THE PROPERTIES BOARD

Jeff Hutton, Chair, Sally Hindman, Secretary, Howard Carlberg, Kelly Mehler and Dave Kobersmith, Staff Member

During my period as chair beginning in April, 2023, a number of ongoing projects were addressed. In addition, short term issues and minor projects were dealt with as needed.

Ongoing projects:

1. Revitalization of the outside play area.

When presented with the congregation's desire to upgrade the play area, we turned to church member, Paul Jacobs of Playground

Partners, to provide guidance as to what issues were in need of attention. In addition, Tennant Kirk contacted members from the University of Kentucky Childcare Aware Resource and Referral Network, who provided additional suggestions. The decision was made to provide for enlarged 'fall area' clearances around fixed structures and to increase the safety of the swing set by changing the configuration of the strap swings. Jeff sought contractor bids to move the walkway fence to address some fall area clearance issues. In addition,



the decision was made to excavate out some topsoil in the play area to accommodate a deeper layer of engineered wood chips as recommended. Signs that indicate age appropriateness of fixtures in the play area will be placed on those fixtures. Concerns with excavation were raised regarding potential rainwater drainage. A play area drainage system is indicated on the 1965 remodeling plan for the Education Wing and it was decided to confirm this before excavation can commence. For the time being, because of drainage concerns, as well as budgetary restraints, further action is on hold.

2. Down Spout Concerns

Dave is reaching out to contractors to inspect gutter and down spout drainage, especially where it suspected that rainwater overflow may be causing building damage.

3. Safety Placards

Jeff is working with Dave to produce fire safety placards, showing locations of exits, handicap accessible areas, restrooms and fire extinguishers for placement at various locations around the church buildings.

4. HVAC Issues

Heating and cooling units fail on occasion despite regular contracted inspection and maintenance. New WIFI have been installed to control heating and air conditioning in the sanctuary and community room.

5. Energy Efficiency Grants

The Properties Board continues to monitor developments to the grant funds that may become available for future projects.

6. Cowan Chapel Lighting

We continue to look for ways to improve the lighting in Cowan Chapel.

7. Maintenance Manual

A printed schedule of basic and regular building maintenance is being developed.

Completed Projects:

1. Electrical Circuit Identification

Dave and Jeff have effectively completed the electrical circuit identification for the entire Union Church physical plant. There are some non-functioning electrical outlets in the older areas of the facility which need to be deemed as safe by a licensed electrician. With help from Kelly Mehler and Sally Hindman, all room switch plates electrical outlets boxes have stickers which identify their panel and breaker. (If we've missed any, please let us know!) Jeff is finalizing a set of electrical drawings showing current panel designations. Panel drawings, showing the location of all electrical breaker panels have been distributed to Property Board members.

2. New TV Mounts

Jeff installed new railing-mounted television mounts for use by choir members and other performers.

3. Historical Marker Relocation

Howard Carlberg re-tapped setscrew holes in the old historical sign and later, he and Dave reinstalled the old sign on a new post on Prospect Street.

4. Sidewalk Safety Paint

Howard Carlberg and Jeff Hutton prepared the concrete and painted lines the sidewalk adjacent to the church parking lot.

5. Fire Suppression Compressor

A new compressor was installed to replace the one used to pressurize the fire sprinkler piping. A regular schedule of maintenance of this unit will enhance performance and safety.

6. Bench Refurbishment

Jeff Melton had kindly replaced the seat and back boards on the benches in the garden behind the church sanctuary. New hardwood is coated with a beautiful weather resistant clear finish.

REPORT OF THE TREASURER & CHURCH FINANCE BOARD

The Finance Board meets monthly to review the income and expenses based on the budget approved by the Congregation.

The Congregation approved a 2023 budget with a deficit of \$24,091.07. The Congregation later approved a mid-course adjustment to the budget with a deficit of \$31,428.53. We ended the year with deficit of \$26,354.09 which was lower than the mid-year adjusted budget deficit. This deficit has been covered from our savings. Our ability to tap into savings is becoming more limited. Finance Committee has been a part of the ongoing discussion in Church Council about gradually reducing our annual deficits by working on strategies to increase income and to lower expenses.

We thank Marty Hensley for his many years of diligent service as a member of the Finance Board. We are also pleased to have Patti Smithson join the Finance Board after her long years of service as Church Financial Secretary. We are pleased to have Robert Rorrer as the new Bookkeeper and thank Shirley Carlberg for her service, as well, as for her help in training Robert. We thank Reda Hutton for all of her work as Church Financial Secretary.





Love demands recollection A Brief History Of More Than A Building

- 1853 The Rev. John G. Fee preaches the equality of all people in God's sight and the abolition of slavery to 11 people in a log meeting house on present day Glades Road. "The Church of Christ in Berea", is founded here, and Fee names the new community "Berea" because "they received the word of God with gladness." (Acts 17:10-11)
- 1855 Union Church pastor John G. Fee and members found Berea College
- 1959 Pro-slavery lynch mob drives Fee and church families into exile in Ohio for the duration of the Civil War
- 1864 Services resume in Berea, Union Church works diligently with freed black families mustered out at Camp Nelson, KY. Many move to Berea.
- 1871 First African-American assistant pastor hired
- 1894 Fee resigns from Union Church, founds "Second Church of Christ," now First Christian Church (Disciples of Christ). Church women found "Womans Industrial" an ongoing poverty outreach to women in Madison and surrounding counties.
- 1901 Fee dies in his home on Chestnut street (site of current City Hall).
- 1903 Member Carter G. Woodson, founder of African-American History Month, graduates from Berea College.
- 1904 "Carl Day Law" enacted to prohibit interracial education of Berea College and Union Church. College appeals to US Supreme court, but is denied. Segregation in Berea begins.
- 1920 Ground Broken for new sanctuary in the presence of new Berea College President William J. Hutchins. Corner stone is laid in 1921 with sermons handwritten by John G. Fee sealed beneath
- 1922 First Worship Service and Dedication held September 17, 1922
- 1928 Esty Organ Installed
- 1939 Fellowship of Reconciliation chapters of Kentucky founded in Union Church Community Room. Date uncertain.
- 1947 Union Church helps form the Kentucky Council of Churches
- 1950 Day Law vacated. Black men and women admitted to Berea College once again.
- 1953 Centennial of the Congregation's Founding
- 1960s Regular blood drives begin in Union Church Community room, continuing to present day
- 1964 Education Wing Added
- 1978 New Steiner-Reck Tracker Pipe Organ Installed
- 1982 Cowan Chapel constructed to honor Rev. Thomas "Scotty" Cowan, pastor from 1955-1966
- 1990 Church members help found The Kentucky Environmental Foundation, working to eliminating chemical weapons stored in Madison County.

1996 His Holiness the Dalai Lama preaches at Union Church morning service.

1997 Rev. Kent Gilbert called as youngest pastor. Now the longest serving except for Rev. Fee.

2000 Peace bell dedicated for new millennium. The bell honors Carl & Ruth (Zimmerman) Eschbach who reconciled prisoners and guards from their Japanese prison camp.

2003 Sesquicentennial Time Capsule Sealed to be opened in 2053

2004 Congregation undertakes intentional year-long study of marriage and family, gender identity and sexual morality. Church adopts non-discrimination policy welcoming all persons to full participation.

2005 Archbishop Desmond Tutu rings Peace Bell following his college commencement address

2009 Mission Statement Developed as foundation for a church renovation

2012-2013 Community Room water issues addressed, New HVAC systems, Fire Suppression added and Offices renovated

2014 Sanctuary renovated with revised pew seating, paint renewal, and new carpeting.

2020 In-person attendance suspended in March due to COVID-19 Pandemic. All Services broadcast or held out of doors. No worship was ever cancelled. Members make more than 5000 masks for distribution.

2021 The new vibrant logo expressing openness and a celebration of diversity is adopted. The phase "love demands" was chosen to answer the question, "Why be a church at all? Why serve in this way? Why proclaim equity, fight poverty, and seek justice in the world?" The answer: because God's love demands.



2022 Pastor Gilbert appointed to Kentucky State Medicaid Advisory Commission, testifies before state legislature calling for policies to eliminate the embarrassing child poverty rate.

2022 Church Re-Opens fully for in-person worship in June with masking precautions.

2022 Handcrafted Audio Visual Desk with new sound and video system designed and built by members of the congregation to assist future generations.

2023 Sanctuary repaired after sprinkler head failure floods the building.

The Fee Memorial Sanctuary of Union Church was begun in 1920 and completed in 1922. It was dedicated September 17, 1922, and it was the congregation's intention to celebrate the "Grace in this Place" in its centennial year. of 2022 Unfortunately, the global pandemic and then a sprinkler head failure damage delayed our plans for a year. With the building restored, we are delighted to welcome the community to this celebration.

We rejoice to remember the past, but our prayer now and always is to actively live into the future. This building was built in 1922 to seat all of Berea. Now we hope that it may still *serve* the entire community—those of every faith, and those of none—in the inclusive spirit of God's impartial love. Whether it be advancing your faith, attending a concert, a community meeting, a recovery group, club, or a community meal, this church is your church too. Welcome, friends. We hope that together we can live and serve as love demands for centuries to come.

With our officers and board members, we recommit ourselves to work and fellowship that makes the radical and inclusive love of God, the beloved community proclaimed by Jesus, and the continuing inspiration of the Holy Spirit visible and real to all.
